


Istanbul Commerce University, an institution established by Istanbul Chamber of Commerce, and Gaza Chamber of Commerce and Industry agree to implement this agreement, believing that the process of international student recruitment can be enriched and international understanding strengthened, and wish to establish relations between the institutions, hereby agree to cooperate with each other under the articles as follows:

1. GENERAL CONDITIONS

- a) This agreement regulates the terms of the international student recruitment to Istanbul Commerce University, in accordance with the availability of both the international student quotes assigned for each academic year and the admission procedure legislated by the university senate.
- b) Gaza Chamber of Commerce and Industry is authorized to administer the international student admission process in the region
- c) This agreement does not bind Istanbul Commerce University to directly grant admission to the candidate students recruited by Gaza Chamber of Commerce and Industry.
- d) On condition that the admission process of the international student candidates recruited by Gaza Chamber of Commerce and Industry is held within the application period assigned by the Istanbul Commerce University Senate, the evaluation and admission process will be decided by both parties.

- e) The admission process is administered under the regulations of the admission process and through the receipt of the application documents, listed in the appendix of this agreement, by Gaza Chamber of Commerce and Industry.

2. DURATION OF THE AGREEMENT

- a) It is understood that this agreement will be in force for a period of two (2) years from September 1, 2015, regardless of the date of signing by the two parties, and subject from time to time to revision or modification by mutual agreement.
- b) Without forwarding any reason, either party shall terminate this agreement by sending 2 months prior written notice (including e-mail) anytime.
- c) Notwithstanding the termination of this agreement as provided in point b, it is agreed that any student, who at the date of termination has been accepted to the program and/or has commenced a course of study at the host institution, may complete that course of study under the terms of this agreement.


3. CONFIDENTIALITY

In case of the failure to inform the other party regarding the new address, any notice and correspondence sent to the former address shall be considered as valid.
