Gaza Movement of Goods Weekly Report

1 Introduction:

Complementing to the four weekly reports prepared during this month, August 2024, this supplement provides a more comprehensive overview to the period from 01/08/2024 to 28/08/2024, allowing decision-makers and key players in the field to view the reality from a broader perspective, and work to find creative and effective solutions to the difficulties and challenges facing the flow of goods into Gaza Strip. The main features of this period are:

- 1. The passage of commodities to Gaza Strip was through only two crossings only: Karm Abu Salem (KAS), which mainly serves the southern part of Gaza Strip, and Erez, which serves the northern part of Gaza Strip, while the Palestinian/Egiptian Rafah crossing is still completely closed.
- 2. The daily average number of entering trucks during the entire period is only 152 trucks per day, while the average before the war was 550 trucks per day, meaning that what is currently entering does not reach 28% of what was entering before the war.
- 3. During the entire period, 78% of the number of trucks passed through Karm Abu Salem crossing, and 22% passed through Erez crossing.
- 4. Food constituted the largest portion, at about 80% of the total number of trucks that passed into Gaza Strip during the entire period.
- 5. The role of the private sector was limited to importing some food items only, while there was a dire need for many essential commodities, such as: other food items, medicines, medical supplies and equipment, clothing, footwear, hygiene materials, fuel car oil and spare parts, solar energy equipment, wood, mobile houses, and others.
- 6. The private sector conistituted about 58% and the humanitarian aid 42% of the total trucks that entered Gaza Strip during the entire period.
- 7. Prices of basic commodities were very high, with some items reaching 5 to10 times of their prices before the war, and in general, they are not within the capabilities of most families in light of the difficult economic conditions, especially since many breadwinners have stopped working.




Figure (1): Number of trucks for each week.




Figure (2): Amount of Tons for each week.




Figure (3): Number of trucks for each type of commodities in each week




Figure (4): Number of trucks for food items in each week




Figure (5): Food items categories and shares by trucks.




figure (6): Number of tons for food items in each week




Figure (7): Food items categories and shares by tons.




Figure (8): Source of commodities by trucks for each weak




Figure (9): Percentage of commodities provider by trucks.




Figure (10): Source of commodities by tons for each weak




Figure (11): Percentage of commodities sources by tons.
